REAJUSTE CONTRATUAL – Em razão do reajuste do valor contratual, previsto no Item 2.7 da Cláusula Segunda do contrato e Anexo IV do 2º Termo Aditivo, com amparo legal no artigo 69, Inciso III, c/c §7º do artigo 81 da Lei 13.303/2016 e artigo 37, XXI da Constituição Federal, as partes resolvem reajustar o valor mensal do contrato conforme abaixo:

1. **Reajuste no percentual de 5,225220% IPCA/IBGE**, o valor do contrato passa a ser conforme a seguir: **I)** o valor por circuito passa de R\$ 787,11 (setecentos e oitenta e sete reais e onze centavos) para R\$ 727,71 (setecentos e vinte e sete reais e setenta e um centavos) ; **II)** o valor mensal do contrato passa de R\$ 3.148,44 (três mil, cento e quarenta e oito reais e quarenta e quatro centavos) para R\$ 2.910,84 (dois mil, novecentos e dez reais e oitenta e quatro centavos); **III)** valor anual do contrato passa de R\$ 37.781,28 (trinta e sete mil, setecentos e oitenta e um reais e vinte e oito centavos) para R\$ 34.930,08 (trinta e quatro mil, novecentos e trinta reais e oito centavos), **com vigência a partir de 01/08/2025.**

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, HCITIS ISV OBO BASA BANCO DA AMAZONIA (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
