REAJUSTE CONTRATUAL - Em razão do reajuste do valor contratual previsto no item 3.2 do Contrato Master de Prestação de Serviços Fb-0459/2023, em consonância ao Art. 69, Inciso III, c/c §7º do Art.81 da Lei nº 13.303/2016 e Artigo 37, XXI da Constituição Federal, o valor mensal do Plano de consumo passa de **R\$7.275,10** (sete mil e duzentos e setenta e cinco reais e dez centavos) para **R\$7.662,14** (sete mil e seiscentos e sessenta e dois reais e quatorze centavos), o valor anual passa de **R\$87.301,20** (oitenta e sete mil e trezentos e um reais e vinte centavos) para **R\$107.269,96** (cento e sete mil, duzentos e sessenta e nove reais e noventa e seis centavos) e o valor do custo excedente passa de **R\$0,052** (cinquenta e dois milésimos de real) para **R\$0,0547** (cinquenta e sete milésimos de real) **com efeitos a partir de 12/07/2025**, conforme Anexo I.
