**DO OBJETO**

**CLÁUSULA PRIMEIRA** – As partes resolvem em comum acordo alterar o anexo V do contrato nº 2023/016, de acordo com o Artigo 81, incisos I e II, Parágrafo Primeiro da Lei 13.303/2016 c/c Artigo 105, inciso II, alíneas “a” e “b”, e inciso IV, alínea “d”, do Regulamento Interno de Licitações e Contratos do Banco da Amazônia, no valor de R\$1.295.672,53, passando o valor total do contrato de R\$5.690.000,00 para R\$6.985.672,53, conforme anexo I.

**DA ALTERAÇÃO**

**CLÁUSULA SEGUNDA** – As partes resolvem em comum acordo promover a alteração qualitativa dos serviços compostos no anexo V do instrumento contratual, no percentual de 23,08% que corresponde a R\$1.313.779,99, passando o valor do contrato de R\$5.690.000,00 para R\$7.003.779,99.

**CLÁUSULA TERCEIRA** – As partes resolvem em comum acordo promover alteração quantitativa dos serviços compostos no anexo V do instrumento contratual, no percentual de 2,54% no valor de R\$177.553,32 passando o valor do contrato de R\$7.003.779,99 para R\$7.181.333,31.

**CLÁUSULA QUARTA** – As partes resolvem em comum acordo promover Supressão dos serviços compostos do anexo V do instrumento contratual, no percentual de 2,74% no valor de R\$195.660,79, passando o valor do contrato de R\$7.181.333,31 para R\$6.985.672,53.


