REAJUSTE CONTRATUAL – Em razão do reajuste do valor contratual, previsto na Cláusula Nona do contrato nº2024/014, com amparo legal no artigo 69, Inciso III, c/c §7º do artigo 81 da Lei 13.303/2016 e artigo 37, XXI da Constituição Federal, as partes resolvem reajustar o valor mensal do contrato conforme abaixo:

1. Reajuste no percentual de **7,10% ICTI/IPEA**, o valor mensal de R\$12.074,52 (doze mil, setenta e quatro reais e cinquenta e dois centavos) passará para **R\$12.931,81** (doze mil, novecentos e trinta e um reais e oitenta e um centavos) e valor global de R\$724.741,20 (setecentos e vinte e quatro mil, setecentos e quarenta e um reais e vinte centavos), para 5 (cinco) anos de contrato passará para **R\$765.621,12** (setecentos e sessenta e cinco mil e seiscentos e vinte e um reais e doze centavos), **com vigência a partir de 08/02/2025**, conforme **Anexo I**.
