O **BANCO DA AMAZÔNIA S.A.**, Sociedade de Economia Mista, vinculado ao Governo Federal, com sede em Belém (PA), na Avenida Presidente Vargas, nº 800, inscrito no CNPJ/MF sob o nº 04.902.979/0001-44, neste ato representado pelo seu Diretor Corporativo - DICOP, Sr. **DIEGO SANTOS LIMA**, brasileiro, casado, graduado em administração de empresas, portador do RG nº 075403072021-5 SSP/MA e do CPF/MF nº 011.772.821-78, residente e domiciliado na Região Metropolitana de Belém/PA, doravante denominado **CONTRATANTE**, e, de outro lado, o escritório **RAMOS, GUTIERRES, SALGADO E HIGASHINO ADVOGADOS**, registrado às Folhas 007/011 do Livro nº 61 de Registro de Sociedades de Advogados, Sociedade de Advogado, com registro na OAB/SP sob o nº 6.025, com sede na Capital do Estado de São Paulo, na Rua São Tomé, nº 86, 11º Andar, Vila Olímpia Corporate Plaza, Vila Olímpica, CEP: 04.551-080, inscrita no CNPJ/MF sob o nº 04.537.024/0001-35, representado neste ato por seu Sócio e Administrador **JOSÉ GUILHERME BOTELHO DE MACEDO COSTA**, brasileiro, solteiro, advogado, portador da OAB/SP nº 306.280 e inscrito no CPF/MF sob o nº 357.031.428-65, doravante denominado **CONTRATADO**, RESOLVEM, com fundamento no artigo 72 e 81, II da Lei nº 13.303/2016 e suas alterações, tendo em vista a justificativa contida no processo administrativo, **ADITAR** o contrato acima referenciado, nos termos da decisão da Diretoria Executiva – DIREX do **CONTRATANTE** datada de 25/11/2025, conforme as Cláusulas a seguir:

CLÁUSULA PRIMEIRA (Do objeto) – O presente Aditivo tem por objetivo o acréscimo aos serviços previstos no contrato 2025/182, visando à inclusão da atuação na **Recuperação Judicial de Odelmo Leão Carneiro Sobrinho e outros**, autos nº **5067169-36.2025.8.13.0702**, que tramita perante a 2ª Vara Cível da Comarca de Uberlândia/MG, sob sigilo de justiça:

- a. - O acréscimo do objeto contratual resultará na alteração do valor do pagamento à CONTRATADA, devendo o CONTRATANTE pagar a quantia total de **R\$600.000,00** (seiscentos mil reais) referente a prestação dos serviços acrescidos, **a título de pró-labore**, o que representa o percentual de acréscimo de 16,67% do contrato, passando o valor total de R\$3.600.000,00 (três milhões e seiscentos mil reais) **para R\$ 4.200.000,00** (quatro milhões e duzentos mil reais) referente ao pró-labore, com amparo legal no Art. 81, inciso II, §1º da Lei 13.303/2016;
- b. - Fica pactuado ainda o valor de 2,5% a título de honorários de êxito em cima do valor da ação.

CLÁUSULA SEGUNDA (Da Dotação Orçamentária): As despesas com a execução do presente contrato correrão à conta das seguintes dotações orçamentárias, para o corrente exercício de 2025, assim classificados:

Disponibilidade orçamentária na rubrica “Honorários Advocatícios – S/ INSS- PJ” – 82.555-7”.

PARÁGRAFO ÚNICO: As despesas relativas aos exercícios subsequentes correrão por conta das dotações orçamentárias respectivas, devendo ser empenhadas no início de cada exercício.

From time to time, HCITIS ISV OBO BASA BANCO DA AMAZONIA (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
